Hi Marla.

Our new social science standards require that our students be able to use primary and secondary sources. The dictionary, a secondary source, defines insurrection as: act of revolting against civil authority or an established government.

The individuals who stormed the Capitol, a government building where government officials were carrying out the Constitutional procedure of certifying the electoral votes, were attempting to revolt against an election result that was free, fair, and not fraudulent as determined by multiple courts, including the highest court in our nation. That by definition is an insurrection. Those individuals that stayed peacefully outside the Capitol and respected police barriers, were protesters.

Question 1 under focus questions asks

- Why are the events at the U.S. Capitol being referred to as an insurrection rather than a protest?
 - As a student, I could define the word insurrection as stated above. I would guess the teacher may have even given them the definition.

Two more questions ask

- What changes do you think the assault should lead to, and what do you think are the biggest open questions to seek to resolve?
 - There are multiple possible responses and questions to ask...increased Capitol security, doing away with the electoral vote, the assault's failure should lead to an increased focus on the 2024 election and using Constitutional methods of creating change (i.e. voting), why is there such a disconnect between what people believe and how do we bridge that divide?
- If you were a lawmaker in Congress right now, how would you address your constituents about the events at the Capitol?
 - Again-multiple responses depending on the lawmaker. Student responses can vary. The bottom line is that lawmakers have a duty to support and defend the Constitution, and our teachers TEACH the Constitution.

The questions on their own are not biased. I hope that helps.
